Overview:



Features:


Login:




Add Clients:


- On the Clients page, you will find an option to add a new client. Click on the "Create" button to initiate the client creation process.
- Once you have filled out all the necessary information, click on the "Create" button to add the client to the system. A confirmation message will appear, indicating that the client has been successfully added.




 After adding the client, you can view the updated list of clients on the Clients page. The newly added client's information will be visible, including their name, contact details.




• We can update clients information add credentials for client side login.




 We can also assign the role to clients as module wise which module is visible to client.



• It's a page to assign permissions of application pages to Users and Roles




The super admin, being the highest authority within the Patient Management

manage client profiles, ensuring seamless administration and personalized care.




Switching from Super User to Client Account:

 As the super user, it's important to log out to maintain the security and privacy of the system. Click on the "Logout" button located at the top-right corner of the screen.




After successfully logging in as a client, your access is restricted to the Patient

Adding a New Doctor in the Patient Management System (PMS):




 After adding the doctor, you can view the updated list of doctors on the Doctors page. The newly added doctor's information will be visible, including their name, contact details.



Initiating New Doctor Registration:


Create New Account to initiate the registration process for the new doctor.

 You will be authenticated, and upon successful login, you will be redirected to the doctor's dashboard within the Patient Management System.




Access the "Appointments" section to view your scheduled patient consultations.
 You can review appointment details, access patient medical histories, and update records as necessary.






Staff Management in the Patient Management System (PMS):


In addition to managing patient data, the Patient Management System (PMS)

• Create New Account to initiate the registration process for the new Staff member.










Adding a New Patient in the Patient Management System (PMS):

 Adding a new patient to the Patient Management System is a straightforward process, ensuring accurate and comprehensive recording of patient information.








Managing Patient Visits in the Patient Management System (PMS):


- In the Patient Management System, efficient management of patient visits is paramount to providing quality healthcare.
- · When the appointment is created then manage the patient visit.




Selecting Patients with Appointments for Today in the Patient Management System (PMS):




 Patient status includes information about their health. Fill all these fields and also add some precautions according to the disease.







Manage Medicine detail for patient in PMS:




 The system generates reports and analytics based on patient statuses, allowing healthcare providers to assess trends, track outcomes, and identify areas for improvement.




• After upload Report we can view, edit, delete and download report from actions.






History of patient in PMS:


Details about past hospitalizations, surgeries, procedures, and their respective

filter by date and time.







Dynamic fields for the patient visit form:

 We can add dynamic fields for the patient visit form. As you can see in the patient status fields are added like Blood group as dropdown and Is sugar patient as checkbox.




